Consultation on discounts, multipliers and seasonal factors for 2023 gas transmission tariffs

On 1 September 2021 the President of URE launched the 4th consultation pursuant to Article 28 of Commission Regulation (EU) 2017/460 of 16 March 2017 establishing a network code on harmonized transmission tariff structures for gas (OJ L 72 of 17.03.2017, p. 29) for gas transmission tariffs concerning the transmission network of Operator Gazociągów Przesyłowych GAZ-SYSTEM S.A. and the transmission network owned by the energy company SGT EuRoPol GAZ S.A.

During the consultation process spanning from 1 September to 31 October 2021, stakeholders may send their comments, opinions and proposals to a dedicated e-mail address: konsultacje.nctar@ure.gov.pl, using an enclosed template.
